REQUIREMENTS, PROHIBITION AND RESTRICTIONS

Date of Garage Sales in last 12 months: _____ Claim of Exemption (sec. 605.350) _____

1. **Permit to be obtained at least two days prior to the date of sale.** Any sale shall be restricted to the hours of 8 a.m. to 6 p.m. and shall not exceed three days in a seven day period.
2. **Two permits are allowed per location within a twelve month period (three days in a seven day period, example Wednesday, Saturday, Sunday of same week).**
3. No property owner or permit applicant who has a business license, as defined in City Ordinance 605.040, shall sell or display for sale any goods, products, materials or commodities of their business at the location where the sale is to be conducted. No person shall accept or take in for sale any goods, merchandise or salesman samples from any commercial business or enterprise on a consignment basis. No person shall purchase for resale, or bring upon his property, articles or items specifically for a sale. However, this provision shall not prohibit two or more people from holding a joint sale at one home.
4. There shall be no display or sale of goods in the front yard or on any street, sidewalk or right-of-way.
5. One sign not larger than 2'x3' advertising such sale may be displayed on the lot where such sale is to be held, and with the written permission of the appropriate property owners two additional signs of like size may be installed elsewhere in the City. Written permission must be attached to this application. List location of additional signs

6. Signs advertising the sale cannot be posted more than three days prior to date of sale and must be removed at the end of the last day of the sale. There shall be no posting or affixing of signs or advertisements of such sale in violation of the City of Creve Coeur Ordinance, Section 605.340H.
7. Nothing in this article shall be construed as authorizing any person to violate St. Louis County Ordinance, Chapter 815, regarding auctioneers.
8. Persons conducting any sale, or the applicant thereof, shall keep the streets, sidewalks and general vicinity of the sale location free from trash and litter.
9. Any use of radios, speakers, microphones, public address systems or other sound amplifying equipment that creates a public disturbance noise, as defined in Section 605.340K of the City Code of Ordinance is prohibited.
10. Parking of motor vehicles is restricted to one side of the street, and where practical shall be restricted to the same side of the street the sale is on. Signs indicating "No Parking by Order of the Police Department" may be provided to the applicant on request, and only after issuance of the sale permit. Such signs are considered temporary, and shall be removed at the close of each day such sale is conducted.
